

General

Tariff applicable for an offer VOD linked at and combined with an offer of television distribution. This tariff is not applicable for multi-territorial services or services to which Sabam grants licenses for fragmented repertoire

Remuneration

1. for a **paying offer to the consumer**, a different remuneration is due depending on whether it is an individual order of a programme (1.1) or a subscription based order (1.2).

1.1. Individual order

A percentage on the “transaction price” (the price the end user pays) is applicable. This percentage depends on the genre to which the ordered work belongs:

- fiction films: 1.375%
- films (of a pornographic nature): 1.000%
- concerts, shows and music shows: 2.750 %
- theatre works (sketches included) : 2.125 % in proportion to the rights actually administered by Sabam
- series (animation or fiction), docusoaps and soaps : 1.375%
- Belgian or foreign films, series (animation or fiction), docusoaps and soaps for which Sabam shall have brought the prior proof of its mandate for the administration of the related grand rights: 3.500 % in proportion to the rights actually administered by Sabam
- documentaries, reports and magazines (all with a journalistic character) : 0.700%
- other (e.g.: news, sporting events, sporting documentaries, quiz shows): 0.350%

Individual order means the purchase of a work by way of a payment per piece, among others by SMS or any other electronic means.

“Transaction price” means the amount invoiced without VAT to the consumer for each programme that has been ordered.

1.2. Subscription based order

1.2.1. - Monothematic subscription

A percentage, corresponding to the genre of the programme proposed, is applicable on the subscription price:

- fiction films: 1.375%
- films (of a pornographic nature): 1.000%
- concerts, shows and music shows: 2.750 %
- theatre works (sketches included) : 2.125 % in proportion to the rights actually administered by Sabam
- series (animation or fiction), docusoaps and soaps: 1.375%
- Belgian or foreign films, series (animation or fiction), docusoaps and soaps for which Sabam shall have brought the prior proof of its mandate for the administration of the related grand rights: 3.500 % in proportion to the rights actually administered by Sabam
- documentaries, reports and magazines (all with a journalistic character): 0.700%
- other (e.g.: news, sporting events, sporting documentaries, quiz shows): 0.350%

Monothematic subscription means a subscription limited to one single category among the categories listed under point 1.1. above.

“Subscription price” means the amount invoiced without VAT to the consumer for subscribing the “On-demand” subscription proposed.

1.2.2. - Multi-thematic subscription

An average percentage of 1.5% on the subscription price applies.

Multi-thematic subscription means a subscription that covers several categories listed under point 1.1. above.

2. for free offers to the consumer, including the free offers related to the subscriptions, a lump-sum is due, corresponding to the genre of programme proposed, calculated as follows:

- fiction films: 0.0301 EUR
- films (of a pornographic nature): 0.0219 EUR
- concerts, shows and musical shows: 0.0659 EUR
- theatre works (sketches included): 0.0457 EUR in proportion to the rights actually administered by Sabam
- series (animation or fiction), docusoaps and soaps: 0.0161 EUR
- Belgian and foreign films, series (animation or fiction), docusoaps and soaps for which Sabam shall have brought the prior proof of its mandate for the administration of the related grand rights: 0.0761 EUR in proportion to the royalties actually administered by Sabam
- documentaries, reports and magazines (all with a journalistic character): 0.0151 EUR
- other (e.g. : news, sporting events, sporting documentaries, quiz shows): 0.0078 EUR

These amounts are to be multiplied by the number of times each work has been ordered by the subscribers during the accounting period concerned.

Instead of the remunerations mentioned under points 1 and 2 above the following can apply :

- a general average rate of 1.5% on all revenues related to the paying “on-demand” offer
- an average lump-sum amount of 0.0278 EUR per work that has been subject to an order within the framework of a free offer.

All amounts mentioned above are without VAT of 6% and are linked with the consumer price index 109,04 (basis 100 = 2013) of December 31, 2019.
